Today, the nineteenth of June

two thousand, appeared before me,

Hajo Bart Hendrik Kraak, civil-law notary in Amsterdam:

Annetmarie Meta Sluijmers, care of Strawinskyalaan 2001, 1077 ZZ Amsterdam, born in Alphen aan den Rijn on the twenty-seventh day of January nineteen hundred and sixty-six.

The appearing person declared:

- that the articles of association of the company with limited liability (*naamloze vennootschap*) ABB ALSTOM POWER N.V. with corporate seat in Amsterdam, having its office at 1181 NB Amstelveen, Burgermeester Haspelaan 45 5/F and filed at the Trade Register under number 34116556 (the "Company") were lastly amended by deed on the thirtieth day of June nineteen hundred and ninety-nine, executed before H.B.H. Kraak, civil-law notary in Amsterdam, in respect of which amendment the Minister of Justice has advised on the twenty-second day of June nineteen hundred and ninety-nine, under number N.V. 1.074.388 that no objections have become apparent;
- that the shareholders' meeting of the Company has decided to amend the articles of association of the Company partially;
- furthermore, it was decided to authorise the appearing person, to enable him to effect the amendment of the articles of association;
- . - that such resolutions are evidenced by written shareholders' resolution to be attached to this deed.

Subsequently, the appearing person declared to amend the articles of association of the Company partially, in pursuance of the referred resolutions, as follows:

1. The name of the company (the "Company") is ALSTOM Power N.V.

Final statement

1. Finally the appearing person declared that the Minister of Justice has, evidenced by the declaration to be attached to this deed advised on the nineteenth day of June two thousand, under number N.V. 1.074.388 that in respect of the current amendment of the articles of association no objections have become apparent.

This deed was executed today in Amsterdam.

The substance of this deed was stated and explained to the appearing person.

The appearing person declared not to require a full reading of the deed, to have taken note of the contents of this deed and to consent to it.

Subsequently, this deed was read out in a limited form, and immediately thereafter signed by the appearing person and myself, civil-law notary, at four hours twenty minutes post meridiem.
