AND we further agree that we will promptly, upon request and without further compensation, do all lawful acts including the execution of all necessary documents, and the giving of testimony that in the opinion of the Assignee, its successors and assigns may be necessary or desirable for obtaining, sustaining, or reissuing United States and foreign Letters Patent, relating to the foregoing assigned rights, and for perfecting, affirming,

recording and maintaining the title of the Assignee, its successors and assigns thereto, and we will generally cooperate to the fullest extent in all matters pertaining to said invention and patents, and said Assignee's title thereto.
