for which we are about to make application for Letters Patent of the United States; and



AND I do hereby authorize and request the Commissioner of Patents to issue the said Letters Patent to the said assignee of our entire right, title and interest in and to the same for the sole use and behalf of the said assignee, its successors and assigns.
