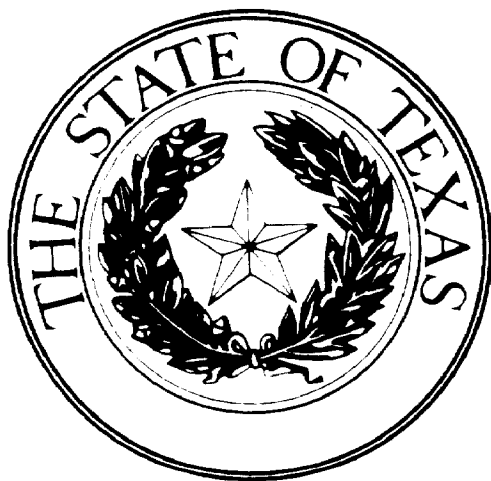

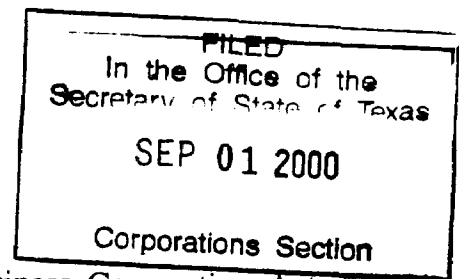

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION**



Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE ONE**

The name of the corporation is **MFD ENTERPRISES, INC.**

**ARTICLE TWO**

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on August 1, 2000.

The amendment alters or changes Article 1 of the original Articles of Incorporation and the full text of the provision altered is as follows:
