ASSIGNMENT

THIS DEED is made the Twenty-third day
of June One thousand nine hundred and ninety-nine
BETWEEN

- (1) BTC INTERNATIONAL LIMITED whose company registration number in England is 2664412 and whose registered address is 10 Fleet Place, Limeburner Lane, London, EC4M 7SH ("BTG"), and
(2) MICHAEL HORROCKS of Frenchay Common House, Bristol, BS16 1LJ ("Prof. Horrocks"), and
(3) ROBERT SKIDMORE of 2 Croft Close, Bitton, Bristol, BS15 6HF ("Dr. Skidmore")

WHEREAS:-

(A) By an Assignment dated 2nd December 1993 made between the parties hereto under which the second and third parties assigned to BTG the invention specified in the Schedule hereto ("the invention")

(B) BTG has agreed to reassign the invention and the United States patent specified in the Schedule hereto ("the patent") to Dr. Skidmore

NOW THIS DEED WITNESSETH as follows:-


1. BTG hereby assigns to Dr. Skidmore the invention and the patent
2. BTG hereby covenants with Dr. Skidmore that it will at the request and cost of Dr. Skidmore execute and do all such documents acts and things as may be necessary for the purpose of vesting in Dr. Skidmore absolutely the patent specified in the Schedule
3. Dr. Skidmore hereby covenants with BTG:-
 - (1) that he will within 90 days of the receipt thereof pay to BTG Fifty per centum (50%) of any payments received in respect of the licensing manufacture sale or other exploitation of the invention and the patent until the aggregate of such payments to BTG amount to the sum of Three thousand nine hundred and twenty-nine pounds and eighty-seven pence (£3,929.87)
 - (2) that he will keep proper accounts of his receipts the subject of sub-clause (1) of this Clause and that he will on request produce the same for inspection by the duly authorised representative of BTG together with any invoices or vouchers relating thereto for the purpose of verification
 - (3) that he will not without the prior written consent of BTG assign or otherwise part with possession of his rights in the invention and the patent (except by way of licence thereunder) until the said sum of Three thousand nine hundred and twenty-nine pounds and eighty-seven pence (£3,929.87) has been paid to BTG
4. Prof. Horrocks hereby consents to the above assignment and waives all rights which he may have to call for assignment to him of the patent
5. BTG is hereby released from its obligations under Clause 4 of the said Assignment dated 2nd December 1993 and the Revenue Sharing Agreement dated 2nd December 1993 made between Prof. Horrocks, Dr. Skidmore and BTG is hereby terminated with immediate effect and the parties are hereby released from their respective obligations thereunder

6. It is hereby certified that the transaction hereby effected does not form part of a larger transaction or series of transactions in respect of which the amount or value or the aggregate amount or value exceeds Sixty thousand pounds (£60,000.00)
