Whereas I, the undersigned, David Thomas Healey, hereby have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled, FILTER MEDIA, identified as U.S. Serial No. 09/698,584, filed October 27, 2000, which application was executed by me on the date set forth therein; and

Whereas, HOLLINGSWORTH & VOSE COMPANY, a Massachusetts corporation having a place of business at 112 Washington Street, East Walpole, Massachusetts 02032, and which, together with its successors and assigns, is hereinafter called "Assignee," is desirous of acquiring the title, rights, benefits and privileges hereinafter recited;

1. 4. 5.
