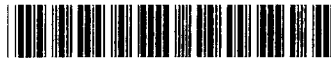

WHEREAS, H.R.P. without further compensation, any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments, and other documents which, in the opinion of counsel for said TIBOR SCHWARTZ, his successors and assigns, may be required or necessary to more effectively secure to and vest in said TIBOR SCHWARTZ, his successors and assigns, the entire right, title and interest in and to said Invention in the United States and foreign countries and improvements, applications, Letters Patent, rights, benefits, privileges and advantages hereby sold, assigned, transferred and conveyed, or intended so to be, and that I will sign any United States applications for reissue which may be desired by the owner of the patent or patents which may be issued for the said Invention or improvements.


