ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, WILLIAM J. BOLOGNA, a citizen of THE UNITED STATES OF AMERICA, and HOWARD L. LEVINE, a citizen of THE UNITED STATES OF AMERICA (hereinafter jointly referred to as "ASSIGNORS"), having invented an invention entitled VAGINAL pH BUFFERING FOR PREVENTING MISCARRIAGE AND PREMATURE LABOR, AND FOR TREATING OR PREVENTING BACTERIAL VAGINOSIS for which application for Letters Patent of the United States of America has been filed by Provisional Application on December 22, 1999, assigned Serial No. 60/171,454, and by utility Application on December 21, 2000, re-filed on December 22, 2000 and assigned Serial No. 09/748,753; and

WHEREAS, COLUMBIA LABORATORIES, INC., a corporation organized and existing under and by virtue of the laws of the State of Delaware and having its place of business at 100 No. Village Avenue, Rockville Centre, New York 11570 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the exclusive right, title and interest in, to and under said invention and in, to and under any Patent or similar legal protection to be obtained therefor in the United States of America and its territorial possessions, and in any and all countries throughout the world.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNORS hereby sell, assign, transfer and set over unto the said ASSIGNEE, its successors and assigns, the full and exclusive right, title and interest to said invention and to all Patents or patent applications or similar legal protection, not only in the United States and its territorial possessions, but in all countries throughout the world, to be obtained for said invention by said application, and to any continuation, division, renewal, substitute or reissue thereof or any legal equivalent thereof in the United States or a foreign country for the full term or terms for which the same may be granted, including all priority rights under the International Convention; and ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue

said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNORS and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents which may be necessary or desirable to carry out the purposes thereof.
