

**ASSIGNMENT**

WHEREAS, I, William T. Auclair, residing at 21 Pinney Street, Winsted, CT 06098, have invented new and useful improvements in:

**FIBER OPTIC CABLE SHIELD BOND SYSTEM**

I further covenant and agree that when requested by the Assignee, and without further consideration, but at the cost and expense of the Assignee, I will, for any and all countries, execute and deliver all applications for patent on said improvements, execute all lawful oaths and other papers, supply to the Assignee all facts and evidence known to me relating to said improvements and the history and development thereof, testify in all interferences, suits, and other legal proceedings, and generally do everything rightful which the Assignee shall consider desirable for aiding in securing,
