

The ASSIGNOR also hereby agrees, at the request and expense of the ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said ASSIGNEE, the ASSIGNEE'S successors and assigns, to obtain and enforce proper patent protection for said invention in all countries.

The ASSIGNOR also hereby grants Ted W. Whitlock, Reg. No. 36,965 the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
