

WHEREAS, I, Jacobus Petrus Maria Dessing, a citizen of the Netherlands, reside at Zalkerbox 6; Hoofddorp NL-2134 EM, the Netherlands, and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled Device and Method for the Automatic Milking and Feeding of Animals, bearing Serial No. 09/807,528 and filed on April 12, 2001;

5. Bind my heirs, legal representatives and assigns, as well as myself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to me or them, all acts reasonably serving to assure that the said inventions and discoveries, the said patent applications and the same could have been held and enjoyed by me, my heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful application documents, including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to me relating to said inventions and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in my control or in the control of my heirs, legal representatives or assigns, which may be useful for establishing the facts of my conceptions, disclosures, and reduction to practice of said inventions and discoveries.
