BETWEEN

- (1) **PAUL DAVIDSON** of 18 Ploughmans Way, Tytherington, Macclesfield SK10 2UN ("**the Assignor**");
- (2) **BAG IN A BOX LIMITED** of 100 Barbirolli Square, Manchester M2 3AB (Company Registration No. 3921733) ("**the Assignee**").

RECITALS

- (A) The Assignor has made an International (*PCT) patent application on 17 July 1998 under the application number PCT/GB98/01924, (publication number WO99/03752) and the title "Packing having a flexible inner bag and a rigid outer casing" ("**the International Application**").
- (B) The International Application has entered the National/Regional Phase as a result of which it is currently pending in a number of territories as listed in the Schedule ("**the National/Regional Applications**").
- (C) The Assignor and the Assignee have agreed that the Applications, International Application and the National/Regional Applications (collectively "**the Applications**") should be transferred from the Assignor to the Assignee for the consideration hereinafter mentioned.

OPERATING PROVISIONS

1 **Assignment**

In consideration of the payment of Two hundred and fifty thousand pounds (£250,000.00) by the Assignee to the Assignor the Assignor hereby assigns absolutely to the Assignee all his rights, title and interest in and to:

- 1.1 the Applications to the intent that the grant of any patents pursuant to them shall be made in the name of and vest in the Assignee together with all rights, powers, liberties and immunities arising or accrued from them including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims and specifications accompanying any application for them or accompanying the Applications prior to the date hereof; and
- 1.2 the right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of the inventions claimed in the Applications including the right to claim priority from it to the extent that the grant of any patents or similar protection shall be in the name of and vest in the Assignee.

2 **Further Assurance**

The Assignor further covenants that at the request and cost of the Assignee it will at all times hereafter do all such acts and execute all such documents as may reasonably be necessary or desirable to secure the vesting in the Assignee of all rights assigned to the Assignee under this agreement, to assist the prosecution of the Application and to assist in the resolution of any question concerning the Application and any patents resulting from it including any proceedings for their infringement or impugning their validity.

This assignment shall be governed and construed in accordance with English law and the parties submit to the jurisdiction of the English courts.




