**ASSIGNMENT**

WHEREAS, Michael A. 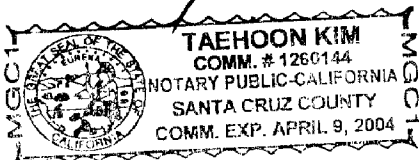

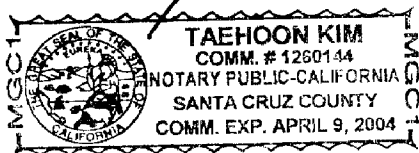
