# ASSIGNMENT

**WHEREAS**, I, Richard L. May, a citizen of the United States of America and resident of Manhattan Beach, California 90366, have invented certain new and useful improvements in a CHEMICAL DISPENSER, for which I have executed application for Letters Patent of the United States, Serial No. 09/639,252, filed on August 14, 2000, and


Siggins, his successors, legal representatives and assigns, in accordance with the terms of this instrument.
