

ASSIGNMENT

WHEREAS, Akiyuki Yoshisato, Kazuhiko Ueda, Akihiko Inoue
and Hiroshi Sakuma

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
