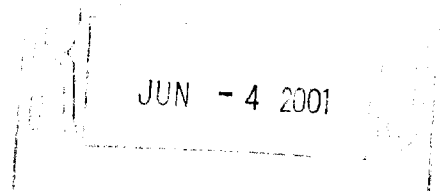

**ASSIGNMENT AND AGREEMENT**

**WHEREAS, Lynn A. Zimmerman** of 9 Spring Street, Rockford, Michigan 49341, **Ronald J.
