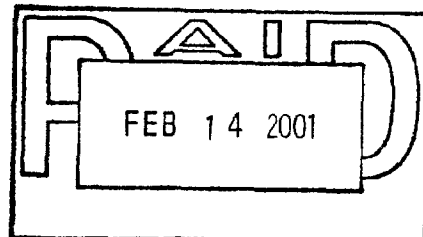

# ASSIGNMENT
