## ASSIGNMENT

WHEREAS we, Ram K. Ramesh and Michael J. And we do hereby authorize and request the Commissioner of Patents of the United States and the Patent Office officials in countries foreign to the United States to issue said Letters Patent to said Cryovac, Inc., as the assigns of our entire right, title, and interest in, to, and under the same, and we hereby further authorize said Cryovac, Inc. to apply for Letters Patent in our name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Arrangement, in any country foreign to the United States.

And we do hereby agree for ourselves and for our heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which Cryovac, Inc., its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part therefor and the said Letters Patent or any of them, the same to be done without any further consideration.
