ASSIGNMENT

WHEREAS we, Edward Lee Mumpower, Ram Kumar Ramesh, and John R. Wolf, residing at 207 Whispering Pines, Moore, SC 29369, 6 Rosemont Way, Greenville, SC 29615 and 306 Pebble Creek Drive, Simpsonville, SC 29681 respectively, have made an invention relating to Lidstock Laminate, which invention is described in an application for Letters Patent of the United States entitled "LIDSTOCK LAMINATE," and filed March 13, 2001 as U.S. Patent Application Serial No. 09/804,842.

Wolf, by these presents do sell, assign, and transfer to Cryovac, Inc., its successors and assigns the full, exclusive, and world-wide right to the said invention and the entire right, title, and interest in, to, and under any Letters Patent which may be granted therefor in the United States, in the territorial possessions of the United States, and in any country foreign to the United States, and in and to all divisions, reissues, continuations, continuations-in-part, substitutions, renewals, reexaminations, and extensions thereof including the full right to claim for any such application the benefits of the International Convention, the same to be held and enjoyed by the said Cryovac, Inc., its successors and assigns as fully and entirely as the same would have been held by me had this assignment and sale not been made.

And we do hereby authorize and request the Commissioner of Patents of the United States and the Patent Office officials in countries foreign to the United States to issue said Letters Patent to said Cryovac, Inc., as the assigns of our entire right, title, and interest in, to, and under the same, and we hereby further authorize said Cryovac, Inc. to apply for Letters Patent in my name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Arrangement, in any country foreign to the United States.

And we do hereby agree for ourselves and for our heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which Cryovac, Inc., its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part therefor and the said Letters Patent or any of them, the same to be done without any further consideration.
