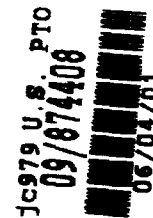

WHEREAS, We are the joint inventors of certain new and useful improvements in **TUNABLE VOLTAGE CONTROLLED OSCILLATOR CIRCUIT HAVING AIDED ACQUISITION AND METHODS FOR OPERATING THE SAME** for which an application for United States Letters Patent has been executed by me concurrently herewith, and
