PATENT RIGHTS ASSIGNMENT

This Assignment is made jointly and severally by Craig D. Hughes, an individual, residing at 1200 South 800 East Avenue, Salt Lake City, Utah 84105, and Reed J. 3. Assignors hereby grant to Assignee the sole and exclusive right to prosecute and have access to the Patent Application and all related applications as described in Paragraphs 1 and 2 above, as well as any opposition proceedings, reissue applications, reexaminations, and nullity or invalidity proceedings. Assignors authorize all governmental bodies having the power to issue patents, reissues, inventor's certificates or utility models to issue a patent, reissue, inventor's certificate or utility model based on

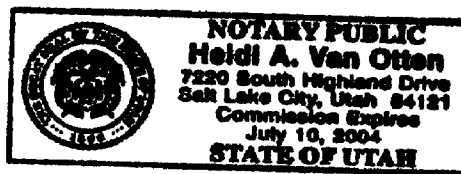

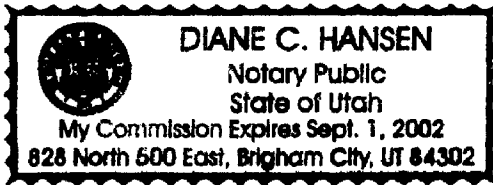
