## ASSIGNMENT OF INVENTIONS

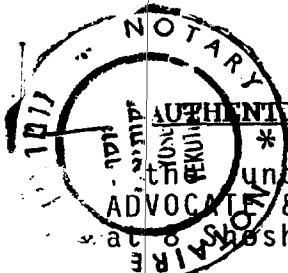
