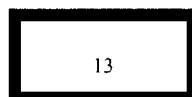

ASSIGNMENT






