ASSIGNMENT OF PATENT APPLICATION

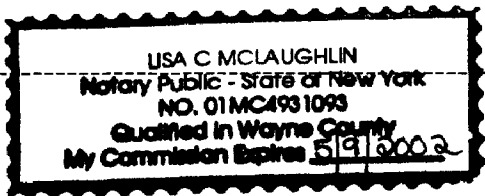

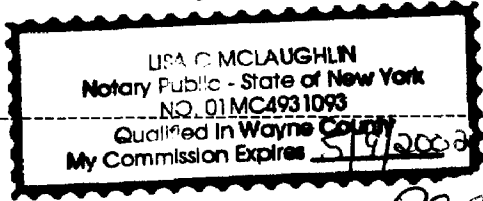

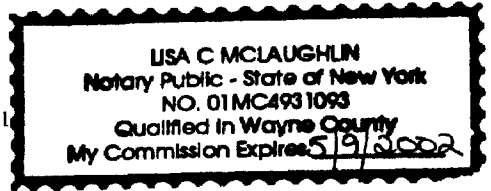
