ASSIGNMENT

WHEREAS, I, Gilbert Thomas Pistole, Jr., a citizen of the United States of America and resident of Katy, Fort Bend County, Texas, have made, with Thomas E. Kretzschmar, a citizen of the United states of America and a resident of Bellaire, Harris County, Texas (hereinafter "Kretzschmar"), an invention in CONTOUR LIGHT PROJECTOR for which we have executed an application for United States Letters Patent on the _______, 2001;

WHEREAS, I represent and warrant that I am the sole owner of a one-half interest in said invention and application for Letters Patent; and

WHEREAS, Kretzschmar is desirous of acquiring the same;

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by me, I have assigned, sold, transferred and set over and by these presents do assign, sell, transfer and set over unto said Kretzschmar my entire right, title and interest in and to (a) said invention and world-wide rights therein, (b) said application, including all divisions, continuations, continuations-in-part, continued prosecution applications and substitutions thereof, and (c) all United States and foreign patents which shall issue on said invention, including all reissues, renewals and extensions thereof, for the United States, its territories and possessions and all foreign countries, including the right to file applications for Letters Patent on said invention in any and all foreign countries, the same to be held and enjoyed by said Kretzschmar, his successors, assigns, heirs and legatees, as fully and entirely as the same would have been held and enjoyed by me, had this assignment and sale not been made.

I warrant and covenant that I (a) have executed no document and have taken no action to in any way dispose of or encumber any interest in the invention, the application or the right to file applications for Letters Patent on the invention in the United States or any foreign country, (b) will not execute any such document or take any such action in the future, and (c) will take no action of any kind which would conflict with this assignment.

I covenant and agree that I will, at any time upon the request and at the expense of said Kretzschmar, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable, in the opinion of said Kretzschmar, to enable and assist said Kretzschmar to (a) obtain Letters Patent, both domestic and foreign, on said invention, (b) establish, maintain and secure title in said Kretzschmar, his successors, assigns, heirs and legatees, to said invention, application and Letters Patent, including making such title of lawful public record, and (c) defend, establish or otherwise preserve the validity of said Letters Patent against any and all infringers, and perform such other acts as are necessary to give full force and effect to this assignment.

I hereby authorize and request the United States Patent and Trademark Office to issue all Letters Patent based on said application and all said divisions, continuations, continuations-in-part, continued prosecution applications, reissues, renewals and extensions to said Kretzschmar, his, successors, assigns, heirs and legatees.
