## ASSIGNMENT

WHEREAS, WE, Stacy S. Cook, a citizen of the United States; and Leland A. Lester, a citizen of the United States; each having a residence listed below (hereinafter referred to as "ASSIGNORS"), have invented a new and useful invention entitled **Distributed Digital Film Processing System and Method**, which is identified as Docket No. ASF00015-PA, for which we have executed an application for Letters Patent of the United States, on February 5, 2001 (the "Invention"); and



ASSIGNORS HEREBY further covenant and agree that they will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any and all facts known to ASSIGNORS

respecting said Invention, and testify in any legal proceeding, promptly sign all lawful papers, execute all divisional, continuing, reissue, reexamination and foreign applications, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives and assigns, to obtain, maintain and enforce proper protection for said Invention in all countries, without further compensation, but at the expense of ASSIGNEE, its successors, legal representatives and assigns.

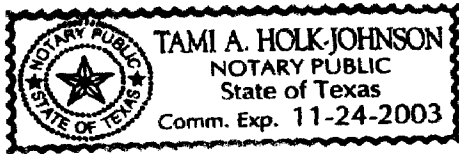
