States, or to such nominees as Lucent Technologies Inc., may designate.

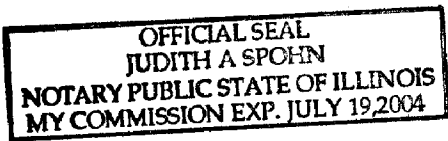

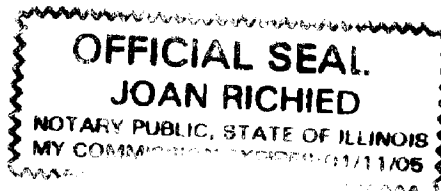
