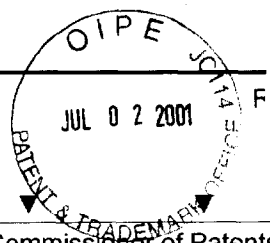

## ASSIGNMENT


