WHEREAS, Ehud Almog, a citizen of Israel, residing at Yegia Kapayim Street 13, 47263 Ramat Hasharon, Israel, hereinafter referred to as ASSIGNOR, has invented and owns a certain invention entitled:

will promptly execute and deliver to ASSIGNEE or their legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce said application, said invention and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.
