ASSIGNMENT

WHEREAS, WE, Douglas K. RICHARDS and Phillip DOWSON, residing at P.O. Box 409, Locust Street, North Apollo, Pennsylvania 15673 and 182A Skyview Drive, Greensburg, Pennsylvania 15601, respectively, have invented certain new and useful improvements in WELDING METHOD, FILLER METAL COMPOSITION AND ARTICLE MADE THEREFROM for which an international patent application was filed under the Patent Cooperation Treaty (the PCT Application) on 27 April 2001 bearing Application No. PCT/US01/13625;

This assignment shall be

binding upon our heirs, executors, administrators, and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors, and/or assigns, as the case may be, of said assignee.
