ARTICLES OF AMENDMENT of the Articles of Incorporation of LockStream.com, Inc. (the "Corporation") are herein executed by said Corporation, pursuant to the provisions of RCW 23B.10.060, as follows:

FIRST: The name of the Corporation is LockStream.com, Inc.

SECOND: Article 1 of the Articles of Incorporation is amended to read as follows:

THIRD: This amendment does not provide for an exchange, reclassification or cancellation of issued shares.
