ASSIGNOR covenants and agrees that it will, at any time upon the request and at the expense of ASSIGNEE, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable, in the opinion of said ASSIGNEE, to enable and assist said ASSIGNEE to establish, maintain and secure title in said ASSIGNEE, its successors and assigns, to said design invention and said Letters Patent, including making such title of lawful public record; and (c) defend, establish or otherwise preserve the validity of said Letters Patent against any and all infringers, and perform such other acts as are necessary to give full force and effect to this

assignment.

ASSIGNOR represents and covenants that no assignment, mortgage, sale, license, pledge, encumbrance or alienation of said design invention or said Letters Patent has been or will be made or entered into which would conflict with this assignment and sale.
