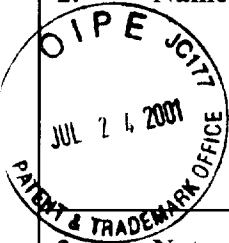

may be granted as fully and entirely as the same would have been held by said ASSIGNOR had this assignment and sale not been made.





