

The undersigned, whose name and address are shown below, hereby amends the Certificate of Incorporation, filed November 6, 1997, of the Oklahoma corporation formerly known as CMS Technetronics, Inc., as follows:

NAME: The name of the Corporation is changed from CMS Technetronics, Inc., to:

SCIPERIO, INC.

- 2. PRINCIPAL OFFICE AND SERVICE AGENT: The address of the principal office of the Corporation in the state of Oklahoma, also to serve as its registered office, is 5202 North Richmond Hills Road, Stillwater, OK 74078-9011 The name of the registered service agent at such address for the Corporation is Dr. Kenneth H. - 3 EXISTENCE: The Corporation is to have perpetual existence.
- 4. PURPOSES: The objects and purposes for which the Corporation is formed are:

 - (b) To research, design, develop and manufacture lasers, electronic equipment, computers, and computer software, and to determine and exploit for profit the commercial application of such technologies; and,
 - (c) To invest its funds or property in real estate, mortgages, stocks, bonds or any other type of investment;
