FOR SAID CONSIDERATIONS, MASTER CHEMICAL CORPORATION hereby covenants and agrees that it has the full title and interest assigned from Mitchell H. Berger and David K. Shaffer and it has the right to assign the same, and agrees that it will communicate to MASCO CORPORATION OF INDIANA or its representatives, any facts known to it respecting said invention or inventions and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which in the judgment of said MASCO CORPORATION OF INDIANA is necessary to vest in and protect the legal title sought to be assigned.
