


**ASSIGNMENT**

**WHEREAS, WE, ROY J. MANKOVITZ and HENRY C. YUEN**, residing at 24236 Park Granada, Calabasas, California 91302 and P.O. Box 438, Pasadena, California 91102, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **APPARATUS AND METHODS FOR A TELEVISION ON-SCREEN GUIDE**, filed May 23, 1997, Application No. 08/862,199.


