UPON SAID CONSIDERATIONS, I hereby agree with said assignee that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I will, at any time upon request, without further or additional consideration but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, reexamined, reissued, or extended Letters Patent of the United States or of any and all foreign countries on said inventions, and on said improvement inventions, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements

as Roe may deem necessary or desirable to perfect Roe's enjoyment of this grant, and render all necessary assistance in making application for and obtaining trademark and service mark registrations of the United States or of any and all foreign countries, and in enforcing any rights or choses in action accruing as a result of such applications or issued trademark and service mark registrations by giving testimony in any proceedings or transactions involving such applications or registrations, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of Johnson and Roe;

AND I request the United States Commissioner of Patents and Trademarks to issue the registrations which may be granted for said marks to said Roe Mfg., Inc., its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said trademark and service mark registrations.
