This assignment is made between

2. Angela Christine DOWNS, a United Kingdom citizen, of 37 Shepherds Way, Liphook, Hampshire, GU30 7HF, United Kingdom (hereinafter "Angela Downs")

Whereas


- a. Michael Downs claims to have made an invention relating to Jamin-type Interferometers and Components thereof (the "Invention") as described and claimed in United Kingdom patent application No. 0018304.6 filed on 27 July 2000 in the joint names of the Michael Downs and Angela Downs (hereinafter "the UK Application")
- b. Michael Downs has assigned, by virtue of an assignment dated 1 August 2000 between Michael Downs and Angela Downs, to Michael Downs and Angela Downs jointly the whole of the property in the Invention throughout the world, including the right to apply for, and to grant of, patents and other forms of protection for the Invention throughout the world, so that the Michael Downs and Angela Downs hold the property in the Invention absolutely as equal joint tenants

- A. Michael Downs hereby sells, assigns and transfers unto Michael Downs and Angela Downs jointly, their successors, legal representatives and assigns, the US Application and all other patent rights for the Invention for the territory of the United States of America, to hold as equal joint tenants
- B. The Commissioner of Patents of the United States of America is hereby authorised and requested to issue letters patent for the Invention solely in accordance with the terms of this assignment to Michael Downs and Angela Downs jointly, their successors, legal representatives and assigns, as the owners of the entire right title and interest therein
