
(1) the inventions as described in said patents and patent applications for the territory of the United States and its possessions and territories and all foreign countries,



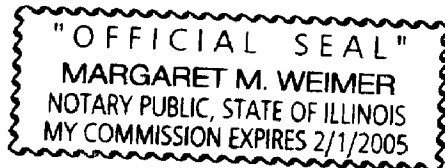
