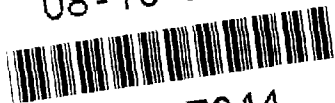

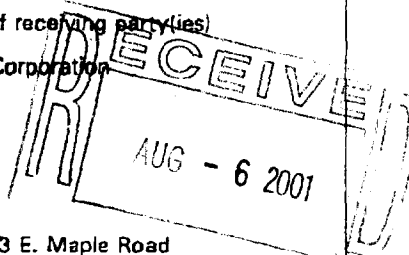

# ASSIGNMENT




