


DEED of ASSIGNMENT

THIS DEED of ASSIGNMENT is made the 23rd day of March 2001

BETWEEN The Post Office, a UK Statutory Corporation whose principal office is at 148 Old Street, London, EC1V 9HQ, United Kingdom ("the Assignor")

AND Consignia plc, a UK registered company (no. 4138203) whose registered office is at 148 Old Street, London, EC1V 9HQ, United Kingdom ("the Assignee")

WHEREAS

- A. The Assignor is the proprietor of a number of non-UK patent and design registrations and applications filed at national, regional and international industrial property offices, including those listed in the Schedule hereto (hereinafter referred to as "the Rights");
- B. The Assignor is the owner of the Assignee;
- C. It has been agreed, for the purposes of internal reorganisation between related companies, that the Rights are to be assigned to the Assignee upon the terms hereinafter appearing.

NOW THIS DEED WITNESSETH AS FOLLOWS:

- 1. "The Rights" as used herein shall mean all Patents, Utility Models, Petty Patents, Short Term Patents, and any other registered protection for inventions; and all Design Registrations, Design Patents, Ornamental Models and any other registered protection for two or three dimensional designs; to the extent that such do not protect said inventions or designs in the United Kingdom; together with any applications therefor, including those listed in the Schedule hereto, and any other such rights.

2. The Assignor hereby ASSIGNS unto the Assignee all the property, right, title and interest in and to the Rights, TO HOLD unto the Assignee absolutely and free from all licences, charges or other encumbrances **TOGETHER WITH** all rights of action, powers and benefits arising or accrued in relation thereto including, without limitation, the right to take or continue proceedings, including opposition proceedings, and to seek and recover damages and seek other remedies for all past infringements thereof; and for the avoidance of doubt, the right to claim priority therefrom, or to file divisional, continuation, continuation-in-part or other applications based thereon. For avoidance of any uncertainty caused by any inadvertent omissions in the schedule hereto, it is hereby confirmed that this Deed of Assignment covers all non-UK designs and patents and pending applications therefor on file at the date shown above.

2. The Assignee hereby accepts the assignment of all rights hereby transferred.

3. If and to the extent that any of the Rights are not hereby assigned, it is agreed that the Assignor and the Assignee shall take such steps as shall be necessary to assign such Rights or to perfect the assignment thereof. At the request and cost of the Assignee, the Assignor shall execute all documents and do all such acts as may be reasonably necessary for the carrying out of this Assignment, and to formally register it at international, regional or national Industrial Property Offices.

4. This Deed of Assignment shall be read and construed in accordance with English law and the parties hereto submit to the non-exclusive jurisdiction of the English Court.




