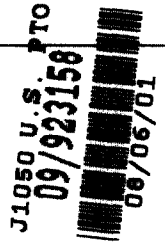

ASSIGNMENT

WHEREAS, Jerry W. Bohn, whose residence is 26283 Highway 22, Barrington, Illinois 60010 (herein called "ASSIGNOR"); has invented a certain new and useful invention for COLUMN AIRFLOW POWER APPARATUS, for which I are about to make application for Letters Patent of the United States;

AND ASSIGNOR HEREBY covenants and agrees that he has full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith;

AND ASSIGNOR HEREBY further covenants and agrees that they will sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain proper protection for said invention in all countries.
