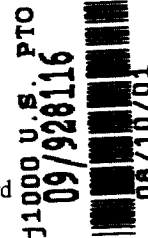

resulting therefrom, insofar as my interest is concerned, to the said ASSIGNEE of my entire right, title and interest.


