ASSIGNMENT

WHEREAS, I Peter James MILNER of 100d Leicester Road, Hinckley, Leicestershire, LE10 1LU, Great Britain, have invented AN OPTICAL REAR VIEW SYSTEM for which I have made application for Letters Patent of the United States of America, and
