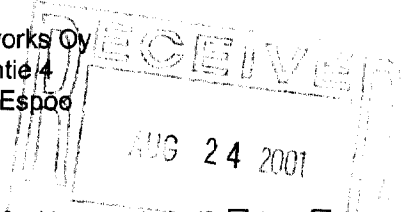

WHEREAS,

- 1. Mika Forssell residing at Bertel Jungin Aukio A C 40, FIN-02600 Espoo, Finland and a citizen of Finland;
