FOR VALUE RECEIVED, Vocal Link, Inc. a Delaware corporation, having a place of business at 26565 West Agoura Road, Suite 305, Calabasas, California (hereinafter called the "Assignor"), hereby sells, assigns, transfers and conveys unto CSVL, LLC, a Delaware limited liability company, having a place of business at 379 Thornall Street, Suite 1100, West Tower, Edison, New Jersey, its successors, assigns and legal representatives (hereinafter called the "Assignee"), the entire right, title and interest, for all countries, in and to certain inventions relating to unified messaging systems and described in **U.S. Patent Application Serial No. 09/505,674, to Robert D. Newman and Sanford Schleicher filed on February 17, 2000** and in and to said application, and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon, and in and to all reissues and extensions thereof, and all applications for Letters Patent or other grants of protection of proprietary rights including, but not limited to, inventor's certificate, utility model, utility certificate, patent of importation, registration of patent and industrial design registration which may be filed, and which may be granted, upon said inventions in any countries or regions foreign to the United States, and all reissues, renewals and extensions thereof; and Assignor hereby authorizes and requests the Commissioner for Patents and Trademarks of the United States, and all officials of countries or regions foreign to the United States having authority so to do, to issue all such Letters Patent or other grants of protection upon said inventions to the Assignee or to such nominees as it may designate.

Assignor authorizes and empowers the Assignee or nominees to invoke and claim for any

application for such Letters Patent or other grants of protection for said inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from Assignor.

Assignor hereby consents that a copy of this assignment shall be deemed a full and formal equivalent of any assignment, consent to file or like document which may be required in any country or region for any purpose and more particularly in proof of the right of the said Assignee or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

Assignor hereby covenants that it has the full right to convey the entire right, title and interest herein assigned and that it has not executed and will not execute any agreement in conflict herewith.

Assignor hereby covenants and agrees that it will communicate to said Assignee or nominees all facts known to it pertaining to said inventions, and will arrange for its officers and employees to testify in all legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid said Assignee or nominees in obtaining,

maintaining and enforcing all lawful patent or other grants of protection of said inventions in any and all countries and regions.


