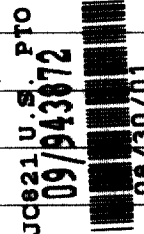

WHEREAS, I, ERIC A. JACOBSEN, am the sole inventor of "TECHNIQUE FOR CONTINUOUS OFDM DEMODULATION" application for United States Letters Patent which is executed of even date herewith; and
