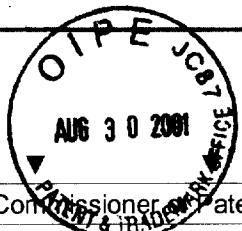

ASSIGNMENT

WHEREAS, I, **Steven S. Ogg**, a citizen of the United States, residing at 979 Turnstone Road, Carlsbad, California 92009, (hereinafter referred to as "ASSIGNOR"), have invented and own a certain invention entitled "**A GOLF BALL WITH MULTIPLE SETS OF DIMPLES**" for which application for Letters Patent of the United States of America has been executed on even date herewith;

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.


