ASSIGNMENT

WHEREAS, David A. Wightman, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled VAPOR COMPRESSION SYSTEM AND METHOD, for a full description of which reference is here made to an application for Letters Patent of the United States filed on July 10, 2001 and assigned Application Serial No. 09/902,900;


