

## ASSIGNMENT

WHEREAS, WE, VIRENDER SETHI, AMY LAMMERT, MARIO MIKULA, and CONSTANTINE SANDU, residing at 1761 N. Pheasant Street, Anaheim, California, 92806; 517 Varmont Place, Monrovia, California, 91016; 22721 Foxridge, Mission Viejo, California, 92692; and 2889 Player Lane, Tustin, California, 92782; respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled COCOA POWDER FOR USE IN MULTI-LAYERED GEL-BASED DESSERT PRODUCTS AND METHOD FOR MAKING SAME, filed September 25, 2000, Application No. 09/669,260.
